

# 4<sup>th</sup> COVID-19 Vaccination

**This is a notification for those between the ages of 18 and 59.**

We will begin to administer the 4<sup>th</sup> dose of the COVID-19 vaccine in Asahikawa in late May.

Those who are eligible for the vaccine are **those over 60 or those who are between the ages of 18 and 59 with underlying medical conditions\***.

Those over 60 will be sent a vaccination voucher for their 4<sup>th</sup> dose once 5 months have passed since their 3<sup>rd</sup> dose, but **those between the ages of 18 and 59 with underlying medical conditions are required to apply for the 4<sup>th</sup> vaccine beforehand** as follows below. Those who do not fall under the above specifications are not required to apply and may ignore this notification.

\*Those between the ages of 18 and 59 with underlying medical conditions are those who meet the requirements under **“Those with Underlying Medical Conditions” (Japanese), and those whom a doctor has stated as being at high risk for severe illness if infected with COVID-19.**

## Who Can Apply

- Those with underlying medical conditions  
(Please confirm the extent of your underlying medical conditions on the enclosed Application for Issuance of 4<sup>th</sup> Vaccine Voucher.)
- Those whom a doctor has stated as being at high risk for severe illness if infected with COVID-19

- We will send the vaccine voucher once 5 months have passed since your 3<sup>rd</sup> dose.
- Depending on the time at which you applied, it may take up to 3 weeks for the voucher to be sent out.

# To those considering receiving their 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> COVID-19 vaccine dose

You are able to receive the 3<sup>rd</sup> COVID-19 vaccine dose 5 months after your 1<sup>st</sup> and 2<sup>nd</sup> doses. You are also able to receive the 4<sup>th</sup> COVID-19 vaccine dose 5 months after your 3<sup>rd</sup> vaccination.



## COVID-19 Vaccine Flowchart



■ This notification and application have been sent out to those between the ages of 18 and 59 as of May 14, 2022.

■ Upon confirmation at the time of your vaccination that you understand both the risks of side effects and the effects of protecting against infection, we will ask for your consent to administer the vaccine. If we do not receive your consent, we will not administer the vaccine.

■ No one should be discriminated against for not receiving the vaccine nor be forced to receive the vaccine by their workplace, school or those around them.
